Chief Williams stated that he has submitted our preapplication for the DWSRF Grant in the amount of \$847,972.00. This grant if approved, will cover the cost of new generators for the ponds and wells, digging of new well on Sunset Drive along with the wellhouse and fence that is needed. Williams stated that the Training and Cyber Security Grant that he applied for was denied, but he is planning to reapply. Chief Williams stated that the Danielsville Police Department will be conducting their first active shooter training for 2025 on April 6th. This training will be held at the old United Community Bank building and at Georgia Metals. Residents can expect to hear simunition being fired. Flash bangs (training decibel level) will also be utilized.
