### Item 1 Welcome

### **Item 2 Old Business**

- Update on USDA Mayor Wideman stated that there is no update at this time.
- Yard Sale Ordinance Mayor Wideman stated that the Yard Sale Ordinance final draft is now
  complete and was emailed to each Council Member and has been reviewed and approved by the
  City Attorney. He asked if there were any questions or changes that need to be made, if not, this
  will be voted on at the next meeting.
- Invoice Cloud Payment System Mayor Wideman stated that he received the contract from Invoice Cloud Invoice Payment System. He stated that the contract reflects all of the fees exactly like what was presented for review at the previous meeting. We were able to get 2 registers and they gave one at half price. We will have to pay Southern Software a 1 time set up fee in the amount of \$1,250.00. Mayor Wideman asked for a motion to approve the new payment system

and the 1-time set-up fee to Southern Software. A motion was made by Council Member Steve Russum and a second was made by Council member Dona Miller. All in favor was unanimous.

### **Item 3 New Business**

- Spectrum Phone System Update City Clerk Kim Davis stated that she has been notified by someone at Spectrum stating that we could get the update version of the Spectrum phone system and 7 new phones for only \$5.00 more per month. The new phone system will allow the office staff to send text messages which will eliminate the need to renew the contract we have with Trumpia when it comes up for renewal in November. Mayor Wideman stated that he thinks that we should move forward with this update.
- Discuss Paving of Madison St and Crawford W Long St Mayor Wideman stated that the quote
  we got from Garrett Paving was incorrect. He stated that we will be able to pave Madison Street
  and Crawford W Long St for \$56,000.00 for both. He stated that the county will be helping with
  Madison St, because they use that road a lot as well as the city.
- SPOLST Renewal We received an email from Christina Baxter with Madison County that stated the City of Danielsville will receive 2.71% of the 1.25:1 population percentage they will use to calculate the totals. The email states that we will receive \$543,429.81 over the next 6 years.
- Elections for 2 Council Seats Mayor Wideman stated that 2 Council Seats will be up for grabs this year which are seats 3 and 4. The Seats are currently being held by Mayor Pro-Tem Steve Russum and Council Member Dona Miller. The Qualifying will be August 18<sup>th</sup> beginning at 8:30am to August 22<sup>nd</sup> at 4:30pm. The qualifying fee is \$87.52

 Council Member Dona Miller asked if all of the fences have been moved in the Northridge Community that are required to be moved. Mayor Wideman stated that we will check when the deadline comes around.
