Item 1 Welcome

- To begin the meeting, Mayor Wideman welcomed everyone to the meeting and the meeting began at approximately 7:04pm.
- Mayor Wideman asked everyone to please stand for the pledge

Item 2 Agenda and Minute Approval

Chief Williams stated that he is applying for a grant for a virtual reality de-escalation for vr-based force training equipment. He stated that the equipment normally costs around \$100-\$150,000.00. He said that the equipment would allow them to train with less lethal, pistol and rifle using scenario-based VR environments. Chief Williams said that he is also working on a grant for the maintenance department for infrastructure and replacing generators.

Chief Willaims said that he now has patrol car unit 192 back from having the water pump replaced. He stated that they will be hosting a GOHS meeting this month which will be catered by Twister Burrito with a license check to follow.

Chief Williams stated that he is planning to send Trevor to field sobriety training in April.
