Item 1 Welcome

- Mayor Michael Wideman welcomed everyone to the word session meeting. The work Session started at 7:06pm.

Item 2 Old Business

- Update on USDA – Mayor Wideman stated that there is no update at this time.

Item 3 New Business

- Security for City Hall – Police Chief Cleve Williams is requesting that bars be added to the window in the police department office. Mayor Wideman asked Cleve to send the proposal to himself and the Council Members.
- New Patrol Car for Police Department – Police Chief Cleve Williams handed out a quote he has received for a new patrol car. He stated that he has close to \$18,000.00 in police seizure funds that he can put towards the new patrol car and GMA will finance the rest at an interest rate of 4.95%. Council Member Steve Russum asked which police care we will be doing away with if the purchase for the new car is approved. Chief Williams stated that the white patrol car will be used as a backup in case one of the other cars break down. Mayor Wideman asked Chief Williams if

he would have the final numbers by the next meeting, and he stated that the quote he handed out does have the final numbers. Council Member Steve Russum asked if we have recovered from the funds that were used from the dredging of the pond and City Clerk Kim Davis stated that we have not recovered all of those funds at this time. Mayor Wideman stated that he thinks it will be best if we do not move forward with the purchase of the new patrol car at this time, and put it off for a few more months.

- Alzheimer's Event – Police Chief Cleve Williams announced that he would like to hold a 5k run and a dunk booth on June 28, 2025 at the Madison County High School. He stated that he has not got the approval yet from the school, and is currently awaiting their response.
- Changes to Front Office Daily Tasks – City Clerk Kim Davis proposed that we begin closing the business day at 3pm each day to help with the closing paperwork. She proposed that all transactions made after 3pm be processed on the next business day. She proposes that this will help the front office staff in so many ways. After a discussion it was decided that this will take place beginning July 1, 2025.
- 1st Reading of Yard Sale Ordinance – Mayor Wideman presented everyone with a new ordinance for yard sales in the city limits. The ordinance states that no permit is required, but city officials should be aware that a yard sale will be taken place. After discussion it was agreed that no more than 3-yard sales should be held at the same residence in a 6-month time frame with several other stipulations.
- Plat Review for Lane Fitzpatrick – Lane Fitzpatrick is requesting to combine 2 lots into 1. The parcel numbers to be combined are D002 025 and D002 026. After Review it was determined that some of the paperwork was filled out wrong and needs to be corrected. However, there should be no reason why these 2 parcels cannot be combined once the paperwork is corrected. Mayor Wideman asked City Clerk Kim Davis to get the paperwork corrected and present it again at the next meeting.


