**Item 1 Welcome**

- To begin the meeting, Mayor Wideman welcomed everyone to the regular business meeting
- Mayor Wideman asked everyone to please stand for the pledge

**Item 2 Agenda and Minute Approval**

- Mayor Wideman stated that everyone should have received the minutes for the Regular Business Meeting and Special Called Meeting Minutes for the meeting that was held on March 10, 2025, and the Work Session Meeting that was held on March 31, 2025. He stated that if there were no questions or changes that need to be made. #### Item 4 New Business






