Item 1 Welcome

Mayor Michael Wideman welcomed everyone to the word session meeting. The work Session started at 7pm.

Item 2 Old Business

Update on USDA - Mayor Wideman stated that City Clerk Kim Davis has reached out to the USDA to try to set up a meeting by email and phone, and has not got a returned call or email at this time.

Item 3 New Business

Turnipseed - David Tyree with Turnipseed was present at this meeting to touch base with the Mayor and Council Members on the project that they have been working on for the sewer system. Mayor Wideman updated Mr. Tyree on the projects that have been completed such as the pond restoration and the sewer expansion that has happened since they last spoke. Mayor Wideman told Tyree that we had to refinance the previous loan that came up for renewal and the audits were not complete when they loan came up for maturity. David said that the USDA money was still available if they chose to move forward with that loan with an interest rate of

- less that 2%. He stated that the funds available are around 5.86 million dollars. Mayor Wideman told Mr. Tyree that he and the council would talk about how they would like to move forward and will get back with him at a later date once the 2024 audit is complete.
- Farmer's Market Mayor Wideman stated hat Council Member Cyle Cox would like to hold the farmer's market again this year and he asked for the Council Member's thoughts. The main concerns of the Council is the time that the City Clerk and Maintenance guys have to put into the preparation and book-keeping. The Council decided that if Cyle would like to do the farmer's market that he handles the book keeping and all of the preparation. Council Member Cyle Cox will think about this and let them know if he will move forward this year.
- Paving of Madison Street Mayor Wideman stated that the county has received some grant
 money for paving the county roads and they are willing to pay for the striping of Madison Street
 if the city will pay for the Paving up to the city/county line.
- Quote for New Meters and Registers Maintenance Supervisor got a quote from Consolidated Pipe for 20 new meters with registers and 20 registers. The quote is for \$10,200.00 plus freight costs. Mayor Wideman asked for a motion to approve the quote for the 20 meters with registers and 20 registers. A motion was made by Council Member Dona Miller and a second was made by Council Member Nancy Federico. All in favor was unanimous.
